## PURPOSE

The purpose of the Student Dress Code is to outline Geelong High's requirements for student dress and appearance and to provide information about uniform purchase and support, dress code implementation and exemption processes

This dress code has been developed by Geelong High School's School Council in close consultation with our school community to ensure that it respects the rights of individual students whilst reflecting the values and interests of our community.

The Student Dress Code aims to:

- promote a sense of identity and pride, cohesion and good order in the school
- allow all students to feel equal
- prevent bullying and competition on the basis of clothing
- ensure students' appearance reflects the expectations of their school community
- enhance the profile and identity of the school and its students within the wider community
- strengthen the spirit of community within the school
- enhance individual student safety and group security
- ensure all students are dressed safely and appropriately for school activities
- prepare students for the expectations of workplaces
- encourage students to present themselves appropriately for a particular role.

## SCOPE

Students are expected to comply with this Student Dress Code while traveling to and from school, during school hours and when attending school activities.

When representing the school, students are expected to comply with this Student Dress Code and may be provided with representative clothing for the occasion.

## UNIFORM AND APPEARANCE

Students can wear any uniform item regardless of gender.

## GENERAL REQUIREMENTS

### HAIR

- Hair must be tidy, of a natural colour, clean and worn in such a manner that will not interfere with school activities.
- All students must be neatly groomed.
- Hair accessories should be aligned with school colours.

## **HATS & SUNGLASSES**

- Hats and sunglasses are not to be worn inside the school buildings
- Geelong High School logo baseball caps. Caps with any other logo are not acceptable.
- Geelong High School Beanie only. Other beanies are **not acceptable**.

## **General appearance**

While at school, travelling to or from school or participating in school activities, students must comply with the following:

- Uniforms must be clean and in good repair
- Uniforms should be clearly marked with the owner's name
- Additional layers of clothing may be worn underneath the uniform, provided these undergarments are completely hidden

## **Health and safety**

Shoulder length or longer hair is to be tied back for student safety in science/ technology subjects.

Jewellery, nails, hair accessories and similar items that interfere with students' ability to engage with school activities safely and fully are not permitted.

School approved Hats / Beanie are not to be worn inside.

- All jewellery worn must be gold/silver, unobtrusive and discreet.
- Students may only wear a maximum of two small sleepers/studs per ear, one necklace, one watch( not a smart watch), one ring and/or one bangle. One nose piercing with a small clear plastic stud is permitted. Other facial piercings are not permitted. Facial piercings and associated jewellery are not permitted. No other jewellery is permitted.
- Staff may require the removal of jewellery for safety purposes.

A minimal amount of makeup is acceptable.

## **PURCHASE OF UNIFORMS**

The uniform is only available from PSW – Uniform Group (111-113 Grove Road, Grovedale VIC 3216)

Second-hand uniform may be bought and sold through Second Hand School Specialists. Their details are as follows: 4 Beauford Ave Bell Post Hill . Trading hours: Tuesday to Friday 3.30pm - 5pm, , Saturday 10am – 1.00pm - Mobile 0422 401 458

Permitted non-branded uniform items can also be purchased from department stores.

The School Council has consulted with the school community and worked to ensure the student uniform is affordable, including reviewing costs with suppliers. However, if you are facing difficulty meeting uniform costs the [Help with school costs and fees](#) page provides advice on support offered by the Victorian Government. If your child is starting prep or year 7 and is eligible to receive support via the [Camps, Sports and Excursions Fund](#), you may be eligible to access the Affordable School Uniform program through [State Schools' Relief](#).

Please contact the principal or to discuss support that we may be able to provide.

## UNIFORM ITEMS

- Students can wear any uniform item regardless of season.
- Approved commemorative uniform items such as the year 12 jumper is accepted as part of the uniform.

## COMPLUSORY UNIFORM ITEMS

### FORMAL UNIFORM

- Official Geelong High School rugby jumper and/ or soft shell jacket and//or ¼ zip active pro Fleece
- Grey trousers (traditional male cut) or Geelong High School navy shorts (traditional male cut)
- Pale blue, short- or long-sleeved shirt, worn open-necked
- White socks
- Black T-Bars or plain, polishable, black leather lace-up school shoes with no visible brands are to be worn
- Check dress in school colours **or** navy tailored shorts (traditional female cut) with a white shirt and white socks
- Navy slacks (traditional female cut) with white socks or Gunn tartan winter skirts can be worn with navy tights
- White, short- or long-sleeved shirt

### ACTIVE UNIFORM

- Official Geelong High School rugby jumper or soft shell jacket, ¼ zip active pro Fleece
- White socks
- Sports shoes
- Appropriate sports shoes with non-marking soles and white socks
- Strive SS or LS Sub Active Polo with school logo and house colours
- Navy sports(active wear) shorts (Ink colour)
- Navy tracksuit pants (Ink colour)
- When representing the school in interschool sports, students must wear their active uniform shorts
- Any Brand Logos / Markings such as Nike / Asics or stripes etc are not permitted

## OPTIONAL UNIFORM ITEMS

- Navy GHS Strive Active shorts with logo
- Navy GHS Stive Active tracksuit pants with logo

## FOOTWEAR

Black dress shoes or all black runners with academic uniform  
Track shoes/runners with active uniform

\*These items are available from Uniform Group – Grovedale.

## IMPLEMENTATION

Geelong High School will ensure that this Student Dress Code and uniform item list is communicated to all families and students through our website and newsletters. We will assist students who may be experiencing difficulties complying with this policy where possible.

It will only be on exceptional occasions that students will be out of uniform. When out of uniform, students must report to the House Office on arrival at school with a note from their parent/carer, explaining the reason for being out of uniform. The House Office will then issue a Uniform Pass if the explanation is reasonable. Students arriving at class without a Uniform Pass will be issued with an after school detention.

Measures taken by Geelong High School to address concerns about student non-compliance with the Student Dress Code will also be addressed in accordance with our Student Wellbeing and Engagement Policy.

## EXEMPTIONS TO STUDENT DRESS CODE

We acknowledge that the enforcement of this Student Dress Code may impact students differently.

Students and their parents or carers may apply either in writing or in person to the principal for an exemption to this Student Dress Code if:

- an aspect of the code:
  - prevents students from being able to attend school or participate in school activities on the same terms as other students because of the [personal characteristics referred to in human rights and anti-discrimination requirements](#)
  - offends a religious belief held by the student or parents/carers
  - prevents students from complying with a requirement of their religious, ethnic or cultural background
- the student has a particular disability or health condition that requires a departure from the dress code
- the student or the parents/carers can demonstrate financial hardship that prevents them from complying with the dress code

When the principal receives a request for an exemption, they will:

- consider the grounds for the exemption request
- explain the process to the student and/or their parents/carer
- guarantee that issues of a personal nature revealed to substantiate the request will be strictly confidential
- encourage the student and/or their parents/carers to support their application with evidence.

The principal or delegate will then try to negotiate a resolution that is acceptable to all parties, including providing advice about support with meeting uniform costs. If an exemption is not allowed, then written reasons will be provided to the student and/or their parents/carers.

## CONCERN ABOUT THIS STUDENT DRESS CODE

Geelong High School welcomes feedback from the school community in relation to this Student Dress Code. If you have a concern or complaint about the Student Dress Code, further information about raising a concern or complaint is available in our school's *Complaint Policy*, available on the school website.

## COMMUNICATION

This policy will be communicated to our school community in the following ways:

- available publicly on our school's website
- other online parent/carer/student communication method
- reminders in our school newsletter
- discussed in student forums

- included in staff handbook/manual
- discussed at staff briefings/meetings as required
- included in transition and enrolment packs
- discussed at parent information nights/sessions
- hard copy available from school administration upon request.

Views on our student dress code have been invited from the whole school community including:

- parent/carers
- teachers and other school staff
- students

The school community consultation invited feedback about uniform cost and affordability. This feedback has been recorded, carefully considered and incorporated into the student dress code policy where appropriate.
